## Privacy Policy HOW DOES FORTUDE USE YOUR PERSONAL DATA?

Most often, we will use your personal data in the following circumstances:

- Where you give us your consent to use your personal data, as required by applicable law; for example when you correspond with us (your consent may be withdrawn by you at any time as set out in this policy); and/or
- For the performance of our contract with you, or to take steps at your request before entering into a contract; and/or
- Where it is necessary for our legitimate interests (or those of a third party); for example, we have a business or commercial reason for using your personal data and your interests and fundamental rights do not override those interests; and/or
- Where we need to comply with a legal or regulatory obligation.

We have set out below, in a table format, a description of all the ways we plan to use your personal data, and which of the legal bases we rely on to do so. We have also identified what our legitimate interests are where appropriate.
